- **Generic crisis scenarios**

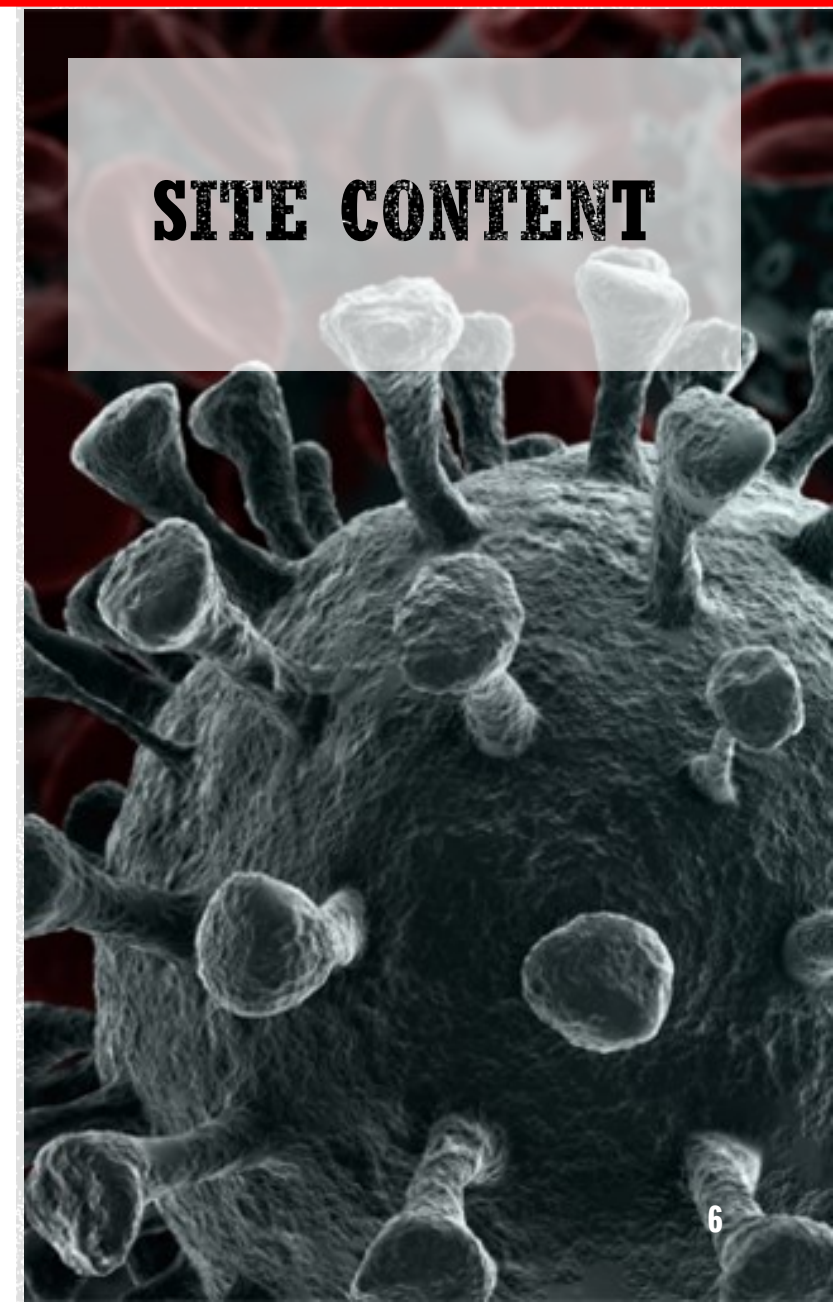
